NOTE: Seawalls will only be permitted if Georgia Power determines no other means of stabilization will control the erosion problem. The maximum height of the structure is one foot (1') above the normal operating high water mark or the point of wrested vegetation, whichever is higher. New seawall construction requires a variance approval from the Georgia Environmental Protection Division of DNR. EPD variance is not applicable on Lakes Oconee and Sinclair.
